

TREASURER CANDIDATES

Lou Trovato - Treasurer

In 1989 my family and I became members of River Hills. My membership has been one of service to our Club. In 1996 I was elected Treasurer and served in that position until 2002. As Treasurer I personally prepared annual budgets and detailed financial statements on a month-to-month basis and ended every fiscal year within budget. In addition, financial statements were presented to the Board and membership at each monthly meeting. I believed then and continue to



believe that it is very important for the Club membership to fully understand how much money they have and how their money is being spent.

Treasurer, I prepared and submitted all RHSC corporate tax returns to the IRS on a timely basis, including a detailed schedule of depreciation of the capital improvements.

During my 6-year tenure as Treasurer, the financial statements were audited every year by an auditing committee using detailed auditing criteria. The Committee confirmed the accuracy of the financial statements and found the Club's financials were totally compliant to their criteria.

In addition to being Treasurer, I have been weekend coordinator at the lodge numerous times. Assistant Treasurers and Board members frequently praised me for the accuracy, clarity and details of the weekend coordinator reports. I pride myself on providing complete and thorough accountings.

I am now retired with more time to devote to the Club and would like to again serve as Treasurer. My past experience in preparing both budgets and financial statements will help stabilize expenses and thus help prevent increases in Club dues, lodge fees and possibly help avoid assessments. The Club should be self-supporting through member usage of the Lodge. I plan to again present the financial reports, audit results, and income tax filing to the membership and the Board on a timely basis.



John Swingler - Treasurer

My family and I have been members of the club for 13 years. We embrace the core values of the club and have had and still plan to have, many fun times at the lodge with fellow members, young, old, family or single. After two very

successful years as treasurer during which I made many improvements and enhancements to our financial records, I have decided to run again. I believe there is more work to be done. The situation regarding our taxes, which I inherited, is unfortunate, but the work I have done to date has been done on explicit advice from the IRS itself. Preparing budgets and managing the clubs finances is no different to my daily corporate responsibilities where I manage a large company that is part of an international corporation.

My decision to run for reelection was made easy with the nomination of fellow dedicated and concerned members who share the same core concerns and objectives that I do. These are: Unification, fiscal responsibility, transparency and membership growth and retention.

I support the generally accepted accounting principles used for most social and nonprofit clubs that the fixed and approved capital costs, be covered by membership dues and that other variable type costs be covered by lodge usage. This is not only equitable to all, but avoids financial uncertainly should usage drop as a result of a poor season of snow or economic trends. Covering the total costs of our club by lodge usage alone is impractical and uncertain. It would

require many more members and this would detract from our core values and mission statement. I support the notion that the calculation method of membership fees and usage rates be included in the clubs bylaws to provide transparency to all.

SECRETARY CANDIDATES

Anne Zaera - Secretary

My participation on the board during this past year has highlighted once again the valuable work it takes to maintain and improve our Club as a whole - this includes our two major assets which are our Members and our Lodge.

I firmly believe that our diverse membership is one of our key strengths. I would like to continue contributing my



energy and skills to ensuring that our club embraces the needs of all our members - whether they joined 40 years ago or just this past season - whether they're in their 'family building' years or in their 'golden' years - all are welcome and each has a very special place at River Hills Ski Club, Inc. of Stamford.

More specifically to the Secretary's role, I view it as having 2 major components -

The short term goal is to accurately record discussions and decisions taken during board and general meetings, and to disseminate those records to the membership in a timely and effective manner. A well-informed membership contributes to greater participation and ultimately strengthens the Club.

There is also a long-term responsibility, which is to maintain and safeguard all the Club's official records. In particular, as Secretary for the Club, I look forward to exceeding the expectations of our membership for timely distribution of Board meeting minutes and decisions as well as discussions which take place during General meetings. I see this responsibility as critical to helping all our members feel connected to the Board and, in the reverse, vital to ensuring that concerns and suggestions from members are appropriately addressed.

I am an HR professional and have experience as a former Treasurer and member of the "Land Committee" in my homeowners association. I think the combination of my history with River Hills, personal experiences, professional expertise and background of volunteerism will help me be an effective Secretary for the members of River Hills.

It is with great sorrow that we pass along an obit below for Charlie Taff, a life member of RHSC, who passed away last month.

CHARLES HENRY TAFF- Charles "Pop" Taff died peacefully at his son's home Saturday evening, Mar. 27, 2010, in Hinesburg, VT. Charlie was born Dec. 30, 1910, in Stamford, CT, the son of the late Henry and Elizabeth Taff. He studied and became a journeyman plumber. Weekends, in the winter, were devoted to skiing.
